

Official Rules for MetaMask Missions

NO PURCHASE NECESSARY TO ENTER AND/OR WIN. AN ENTRY MADE WITHOUT A PURCHASE HAS THE SAME CHANCES OF WINNING AS AN ENTRY MADE WITH A PURCHASE. VOID WHERE PROHIBITED.

1. The promotion sponsor is Consensys Software Inc., located at 5049 Edwards Ranch Road, Fort Worth, Texas 76109. All inquiries may be directed to that address or to notices@consensys.io.
2. To be eligible to participate in the promotion, you must be at least 18 years of age and able to prove your identity and age using a government-issued ID upon request.
3. The promotion begins on July 21st (9am EST) and concludes on August 8th (10pm EST).
4. You may enter the promotion by either method outlined below:
 - a. **Method 1:** No purchase is required to enter the three weekly Sweepstakes with this method. You can enter by minting the opt-in Missions Pass NFT using your MetaMask wallet through [this link](#). Minting the NFT is required to participate in the sweepstakes and counts as a single entry for each weekly sweepstake. When you mint the NFT, you only pay gas determined by the blockchain. Only one wallet address can be entered per person, and it must be associated with a MetaMask wallet. NFTs minted on or after July 16, 2025 will be considered valid for entry into the sweepstakes.
 - b. **Method 2:** Once you have minted the NFT, every weekly mission (consisting of bridging or swapping specific tokens or on specific networks) correctly executed on MetaMask Web, Extension, or Mobile will grant you additional entries into that week's sweepstake (see Table 1 for mission information). You must perform the swaps or bridges using the MetaMask wallet address you used to mint the opt-in NFT.

Table 1

Mission Type	Task	Entries
Token Specific (two per week)	Swap or bridge eligible tokens on, to, or from a specific network using required amount	1, 5, or 10 sweepstake entries (based on amount)
Network Specific (two per week)	Perform all 10 swap or bridge transactions on specified network	10 sweepstake entries

Please refer to the MetaMask Missions token and network instructions each week in the MetaMask Missions portal to view the eligible tokens, required transaction amounts, and eligible networks for that week's missions. Transaction requirements vary by token (e.g., most tokens may require transacting 10, 50, or 100 tokens, while others such as \$WBTC and \$COMP may require transacting fractional tokens).

For token-specific missions (two per week), you can earn 1, 5, or 10 additional entries based on the amount of tokens swapped or bridged on MetaMask. Required amounts, eligible tokens, and eligible networks are determined weekly and are available in the token and network instructions in the MetaMask Missions Portal.

For network specific missions (two per week), you may earn 10 additional entries for that week's sweepstake by executing all 10 transactions (bridge or swap) on that specific network. We will conduct a weekly snapshot of on-chain bridge and swap transactions made on MetaMask within four days following the end of each of the three sweepstakes weeks. Only on-chain transactions captured in this snapshot will be included in the sweepstakes.

If you complete all four weekly missions within the five days of any given week, the 2x multiplier will be activated and your total number of entries earned that week will be doubled.

Note: You will not be entered into the sweepstakes if you make transactions without opting in by minting the NFT. Requests for confirmation of receipt of entries will not be acknowledged. The sponsor shall not be held liable for any incorrect or inaccurate submissions by participants. Participants are solely responsible for ensuring the correct wallet address is provided during the NFT minting process.

5. You may be disqualified from participating if you violate these official rules or otherwise attempt to defraud the sponsor, including by entering using false or misleading information or accounts.
6. If you are located in the United States and have received a promotion reward(s) with a combined value of \$599 USD or more from Consensys within the past 12 months, you are not eligible to participate in this promotion.
7. Each week, a number of eligible wallet addresses, determined by the total number of entries awarded that week (see Table 2 below) will be randomly selected as winners. Prizes will automatically be distributed to the winning users' wallets during the following week. Winners are limited to one prize per person in this promotion. We will also publish

a list of the first four characters of the winning wallets on MetaMask's X account.

8. Each winner is solely responsible for reporting and paying any and all applicable taxes related to the prize(s). Potential winners should consult an accountant or tax professional to determine tax implications in accepting and using (including conducting transactions of) any prize.
9. This promotion will run as a series of 3 sweepstakes with a weekly prize pool determined by the total number of entries distributed each week (see Table 2 above).
 - a. From July 21, 2025 to July 25, 2025 (i.e., week 1), the prize pool and number of winners of either \$500 worth of \$aUSDC or \$500 worth of \$ONDO will be determined by the number of entries distributed that week (see Table 3).
 - b. From July 28, 2025 to August 1, 2025 (i.e., week 2), the prize pool and number of winners of either \$500 worth of \$EURE or \$500 worth of \$LDO will be determined by the number of entries distributed that week (see Table 3).
 - c. From August 4, 2025 to August 8, 2025 (i.e., week 3), the prize pool and number of winners of either \$500 worth of \$COMP or \$500 worth of \$WBTC will be determined by the number of entries distributed that week (see Table 3).

Note: The value of each prize (i.e., "\$500 worth" of a given token) will be calculated based on the fair market value of the applicable token at the time of prize distribution to the winner's wallet address.
